

Fulbright Scholar Program: Legacy



Senator J. William Fulbright (1905-1995)

“International education exchange is the most significant current project designed to continue the process of humanizing mankind to the point, we would hope, that nations can learn to live in peace.”

- Established 1946
- Sends U.S. academics and professionals overseas and brings scholars and professionals from abroad to the U.S.
- Sponsored by U.S. Department of State’s Bureau of Educational and Cultural Affairs
- Administered by the Institute of International Education (IIE)
- 360,000+ Alumni worldwide including 53 Nobel Prize winners and 30 heads of state or government



Fulbright Arctic I: by the Numbers

- 8 Nations
- 17 Scholars, 2 Co-Lead Scholars
- 12 Disciplines
 - Anthropology, Biological Sciences, Economics, Engineering, Environmental Sciences, Geography, Law, Political Science, Public Health, Sociology, Studio Art, Urban Planning
- 3 Thematic Working Groups, 4 Focal Areas
 - Water, Energy, Health and Infrastructure
- 18 Months



Fulbright Arctic Initiative II: Program Details

- 18 months: Spring 2018-Fall 2019
- Three in-person seminar meetings
- Individual Fulbright research exchange visit (6 – 12 weeks)
- Ongoing virtual collaboration
- Research Themes: **Resilient Communities & Sustainable Economies**

Research Themes

- Collaborative research will be built around two overlapping and inter-related themes:
 - **Resilient Communities**
 - **Sustainable Economies**
- Applicants will select a theme and explain how their research fits into these overarching areas of inquiry



Individual Exchange Visit

- Minimum of 6-weeks up to 3 months
- U.S. grantees will complete exchange visit in one of the 7 other Arctic countries.
- Non-U.S. grantees will complete exchange visit in the U.S.
- Letter of invitation recommended but not required



Fulbright Arctic Initiative II: Eligibility

- Open to scholars at all career stages, to include applied researchers, professionals, and Indigenous and traditional knowledge experts active in the academic, public or private sectors.
- At least four of the scholars will be selected from the United States; at least one scholar will be selected from each of the other Arctic Council member states.



Eligibility (cont.)

- Applications accepted from Arctic Council nations: United States, Canada, Denmark, Iceland, Finland, Norway, Sweden or Russia.
- Non-U.S. applicants must be citizens of the country from which they are applying and residing in that country at the time of application
- U.S. citizenship and permanent residency in the United States is required for U.S. applicants
- Preference will be given to early or mid-career academics, applied researchers and/or professionals with research experience in the public, non-profit, or private sector
- A Ph.D. or equivalent professional/terminal degree is preferred. For professionals and practitioners outside academe, recognized professional standing and substantial professional accomplishments are required.
- Non-U.S. Scholars must demonstrate a proficiency in English



Financial Support and Benefits

- \$40,000 (USD) grant award per grantee
 - Supports travel to group program meetings, travel and maintenance for the exchange visit, research materials, and assistance
- Accommodations and meals for full group seminar meetings are provided independent of the grant award
- Limited accident and sickness insurance coverage



Application Deadlines

- International Applicants:
MONDAY, OCTOBER 16, 2017
 - International applicants should contact the Fulbright Commission in their home country
- U.S. Applicants:
MONDAY, OCTOBER 30, 2017
 - U.S. applicants submit applications to IIE



Timeline

- Notification of Selection: February 2018
- Opening Group Meeting (Canada): May 2018
- Mid-year Group Meeting (TBD): February 2019
- Individual Research Exchange Visits: Complete by September 2019
- Final Group Meeting (United States): Fall 2019
